## KA AIN

### Jinglamkhmat.

Ha kaba ki Elaka ba don mynta ki long ki kyntoit hima ba la wan pateng naduh mynbarim ha ka rukom synshar hima ki riewlum trai shnong ha Ri Jaintia State Meghalaya bad ha kaba ki Dorbar Shnong hapoh kita ki Elaka ki long ka bor synshar shnong jong ki nongshong shnong riewlum trai ri ha kine ki lum naduh ki por barim bajah.

BAD

Ha kaba u Dolloi/Sirdar u long u khlieh nongsynshar ba wan pateng kat kum ki riti ki dustur bad u long u nongtrei kam rangbah bad uba ha khlieh ia ki Shnong badon ha kata ka Elaka, bad ba ka jingjied, jingthung kam ban bat ia ka kam Dolloi/Sirdar bad Waheh Shnong la ju pynlong na ka por sha ka por da la ki Elaka bad la ki Shnong hapoh ka jingpeit jingkhmih ka District Council.

BAD

Ha kaba la idei ban thaw ki kyndon ain kiba iadei bad ka jingseng Elaka bad seng Shnong bad ha kaba buh beit ia ki bor, ki kamram bad u pud treikam jong kine ki nongkitkamka ban kythup naduh ka jingjied bad jingthung kum u Dolloi/Sirdar bad Waheh Shnong katkum ba idonkam ha ka kam synshar khaddar ka Jaintia Hills Autonomous District katkum ba la pruid dak ha ka Sixth Schedule ka riti synshar ka Ri India.

Kumta, ka District Council jong ka Jaintia Hills Autonomous District ha kaba pyntreikam ia ka bor ba la pynkup ha ka ban thaw ain hapoh ka Clause(c) na ka bynta ka jingseng Shnong lane Town Committee bad ka bor jong ki, (f) ki kam ba iadei bad ka jingsynshar Shnong ne Town Committee, (g) ka jingthung kam bad hiar pateng jong ki khlieh nongsynshar bad ki Waheh Shnong bad (j) ki riti ki dustur ha ka imlang sahang kiba hapoh ka sub-paragraph (1) jong ka paragraph ba 3 jong ka Sixth Schedule ka Constitution ka Ri India bad kiwei kiwei ki bor ba la pynkup ha kane ka liang, la thaw hangne ia ka Ain kaba yn mynjur da u Lat na ka bynta ban pyntrei kam hapoh Jaintia Hills Autonomous District ha ka rukom ba la pyni hangne.

1. **Ka Kyrteing, ki pud treikam bad ka jingsdang (short title, extent and commencement): -**

- (1) Ia kane ka Ain la khot ka Jaintia Hills Autonomous District (Ka Ain ban Seng Elaka bad Seng Shnong bad ka Jingjied, Jingthung, ka Bor, ka Jingtreakam bad u Pud treikam jong ki Dolloi/Sirdar bad Waheh Shnong) Act, 2015.

(2) Kan trei kam ha baroh u pud ka Jaintia Hills Autonomous District.

(3) Kan trei kam noh shisyndon.

2. **Jingbatai (Definition):** - Ha kane ka Ain lynda donkam da kumwei pat, kine ki jingbatai harum ki long ki jingmut jong ki ktien ba la pyni hangne.

(1) "Adult" (Kiba la san): - Ka mut ia u/ka briew ba la dap 18 snem ka rta shaneng kiba shong bas ah ha ka shnong hapoh ka Elaka.

(2) "Custom" (Riti-Dustur): - Ha ka jingiadei bad kano kano ka Elaka ka mut ki Rule, ki rukom ba ju leh kiba iadei bad ka jingjied, jingthung Dolloi/Sirdar bad Waheh Shnong kiba ju don ha kata ka Elaka, kiba dang iai bteng bad iai bud ryntih bad ba la ioh ia ka jingithuh ki bor ka Ain ha kata ka Elaka.

(3) "Customary Functionaries" (Ki nongtrei kam kat kum ki dustur): - Ka mut U Lyngdoh lane Pator lane Sangot lane Basan lane uno uno u wei pat uba la thung da u Dolloi bad ka Dorbar kat kum ki riti ki dustur ba la ithuh da ka Executive Committee.

(4) "District": - Ka mut ka Jaintia Hills Autonomous District.

(5) "District Council": - Ka mut ka Jaintia Hills Autonomous District Council.

(6) "Dolloi ne Sirdar": - Ka mut u khlieh nongsynshar Elaka ba kat kum ki dustur ba ioh pateng ia uba la jied kat kum ki jingaibor kane ka Ain.

(7) "Dorbar Elaka": - Ka mut ka Dorbar paitbah katkum ki dustur ka ban kynthup ia baroh ki briew ba la san jong ka Elaka bad ba la ithuh da ka Executive Committee.

(8) "Dorbar Shnong": - Ka mut ka Dorbar pyllun ka Shnong ka ban kynthup ia baroh ki nongshong Shnong ba la san jong ka Shnong ba la thung da u Dolloi/Sirdar ka Elaka bad ithuh da ka Executive Committee.

(9) "Elaka": - Ka mut ka kyntoit hima ba la don pateng la pateng kynthup ia ka jingsynshar Sirdar katkum ba la pyni ha ka Appendix-I lane kano kano ka Elaka kaba lah ban seng ne thung da ka Executive Committee hapoh ki kyndon ba ai bor da kane ka Ain.

(10) "Ilekshon" (Jingjied): - Ka mut ka jingjied sha ka kam Dolloi/Sirdar bad Waheh Shnong.

(11) "Eligible Clan" (Jait kur Dolloi/Sirdar): - Ka mut ka jait ne kur ba la pyni ha ka Appendix-II kiba katkum ki dustur ba dang treikam ha kata ka Elaka kiba lah ban bat ia ka kam Dolloi/Sirdar.

(12) "Executive Committee": - Ka mut ka Executive Committee jong ka Jaintia Hills Autonomous District Council.

- (13) "Executive Dorbar": - Ka mut ka Committee Elaka kaba kynthup ia u Dolloi/Sirdar bad kiwei pat ki dkhot napdeng ki briew ka Elaka ki ban jied da ka Dorbar Elaka bad mynjur da ka Executive Committee.
- (14) "Executive Member": - Ka mut u dkhot ka Executive Committee.
- (15) "Indigenous Tribe" (Riewlum trai ri): - Ka mut ki riewlum nongshong shnong ha Jaintia Hills naduh ki por barim bajah, kata ki Pnar, ki Khasi, ki War, ki Bhoi, ki Biate bad ki Hmar (ba shong ha ki Shnong Khaddum bad Sialkan).
- (16) "Local Authority" (Bor synshar ha ki jaka): - Ka mut ka Municipal Board, Town Committee lane Cantonment Board lane kiwei pat ki bor synshar kiba don ha la ki jaka, lane kiwei pat ia kiba lah ban thaw bad pynkup bor da ka Sorkar kmie, Sorkar Jylla bad Autonomous District Council.
- (17) "Offence" (Kam Beain): - ka mut ka kam beain (jingpynkhein ain) hapoh ka Indian Penal Code ne kano kano ka ain ba dang trei kam ha ri India bad ka kynthup ruh ia ki jingleh ba pynhiar dor ne pyrshah ia ka akor ka burom.
- (18) "Office of profit" (ka kam ba don jingioh myntoi): - Ka mut ka kam ba bat hapoh ka Sorkar jylla ne Sorkar kmie ne Autonomous District Council, ne Municipality ne bor synshar ha la ka jaka ne Seng kamai (Corporate body) kaba don ka jingsiew tulop ne kano kano ka jingsiew.
- (19) "People of the Elaka" (u paid ka Elaka): - Ka mut ia ki trai shnong ba shong ba sah pura hapoh ka Elaka (briew ba long ki nongshong shnong ba shisha ka Elaka).
- (20) "Puja Land" (Khyndew niam): - Ka mut ka khyndew hali ba lait khajna ba la bat bad rep da u Dolloi/Sirdar lane uno uno u nongtrei kam niam bad ia ka jingioh ba mih nangta la pyndon kam ban siew ia ka jingpynlut ha ka leh niam leh rukom katkum ki dustur ka Elaka.
- (21) "Reserved Forest" (Law Adong): - Ka mut ia ka khlaw ba la tyngkai da ka Elaka ne Shnong, kum ki khloo kyntang, khloo Lyngdoh, khloo niam bad khloo shnong khlem da kynthup ia ki khlaw ri-sumar ka District Council bad khlaw reserved ka Sorkar jylla.
- (22) "Returning Officer": - Ka mut ia u Ophisar ba la thung da ka Executive Committee ban trei kam bad pyniaid ia ka jingjied (Ilekshon) Dolloi/Sirdar ha kano kano ka Elaka.
- (23) "Sanad": - Ka mut ka Iktiar ba la ai da ka Executive Committee ryngkat bad ki kyndon ba thikna ha ka jingthung ia ki Dolloi/Sirdar bad Waheh Shnong ha kano kano ka Elaka.

(24) "Service Land" (Khyndew Hali Rek): - Ka mut ia ka khyndew hali Rek balait khajna ba la bat bad rep da u Dolloi/ Sirdar ne uno uno u nongbat/nongtrei kam katkum ki dustur jong ka Elaka kum ka bai nong jong ka jingshakri ba u ai ia ka Elaka.

(25) "Village" (Shnong): - Ka mut ka jaka ba shong bas ah ki briew kynthup ia ki dong ha ki sor bah ne sor rit kaba don la u pud u sam ba thikna ba la pynskhem da u Dolloi/Sirdar bad ithuh da ka Executive Committee.

(26) "Waheh Shnong": - Ka mut ia u briew bala jied da ka Dorbar Shnong ban long u Waheh Shnong bad bala ithuh da ka Executive Committee.

**3 (1) Kaba seng Elaka bad u pud u sam: -**

(a) Ki Elaka ba don mynta kumba la pyni haka Appendix-I jong kane ka Ain ki long kiba la don bad pynskhem hapoh Jaintia Hills Autonomous District.

(b) Ka Executive Committee naduh ka tarik ba la pyntrei kam ia kane ka Ain kan pynmih ka jingpynbna paitbah ha ka Gazette jong ka Meghalaya ia ki jingtip kiba iadei bad ka jingheh jong ki pud sawdong jong kawei pa kawei ka Elaka ba la pyni ha ka Appendix-I. Ha kata ka jingpynbna yn thoh ruh ia ki kyrteng jong ki Shnong badon hapoh kawei pa kawei ka Elaka.

(c) Ia kano kano ka jingiakhajia pud hapdeng ki Elaka dei ban phah sha ka Executive Committee ban bishar bad ka rai jong ka Executive Committee kan long kaba kut.

(d) Ki lingbishar Sorkar kin ym lah ban shim bishar ia kano kano ka jingiakhajia kaba iadei bad u pud u sam Elaka.

(2) (a) Ka Executive Committee, da ka jingmynjur ka District Council ha ka jingiashong Dorbar jong ka, ka don ka bor ban thaw Elaka thymmai da kaba pyniasohlang ne pynkhlad ia ka Shnong ne ki Shnong na ki Elaka ba don mynta ia kiba la pyni ha ka Appendix-I.

(b) Ka Executive Committee ha kaba thaw Elaka thymmai, ka dei ban da pynthikna shwa ia ki jingkwah bad jingdonkam jong ki ba bun na ki briew kiba shong ha kita ki Shnong ia ka jingdawa ban thaw Elaka thymmai ha ka ban wanrah ia ka jingsynshar kham jan sha ki briew.

(c) Ka Executive Committee kan pynmih ka jingpynbna paitbah ha ka Gazette ka Sorkar Meghalaya ia kata ka jingthaw Elaka thymmai ryngkat bad ka jingheh ki pud sawdong bad ki kyrteng jong ki Shnong ba kynthup hapoh kata ka Elaka.

Ia ka kyrteng jong kata ka Elaka ba thaw thymmai, dei ban pynrung ha ka list ki Elaka ha ka Appendix-I.

- (d) Ka Executive Committee ka don ka bor ban thaw ia ki rul kiba dei ia ki rukom pyniaid Ilekshon, ka jingthep vote, ki nongialeh Ilekshon, ka por trei kam bad kiwei kiwei ha ka jing iadei bad ka Ilekshon ha ka Elaka thymmai.

Kita ki rul ba thaw da ka Executive Committee kim dei ban long pyrshah ne iapher na ki kyndon jong kane ka Ain ha kaba iadei bad ka bor bad jingtrei kam jong u Dolloi/Sirdar.

Nangta shuh shuh kata ka Rul ba la thaw da ka Executive Committee kan trei kam tad ynda la ioh ia ka jingmynjur ka District Council ha ka jingiashong Dorbar (Session).

- (e) Ka Executive Committee ka don ka bor ban thung Acting Dolloi/Sirdar ha kata ka Elaka thymmai, hadien kata kan pynlong ia ka jingjied (Ilekshon) Dolloi/Sirdar hapoh hynriew bnai naduh ka tarik ba la pynbna paitbah ba la thaw/seng ia kata ka Elaka thymmai.

**4. Ka jingjied (Ilekshon) Dolloi/Sirdar: -**

- (1) Haba ka ophis u Dolloi/Sirdar jong kano kano ka Elaka bala kdew ha ka Appendix – I ka thylli, ka Executive Committee hapoh ki kyndon kane ka Ain bad ki Rul bala thaw, kan pynlong ia ka jingjied (Ilekshon) Dolloi/Sirdar katkum ki dustur hiar pateng ba dang trei kam ha kata ka Elaka, bad ia kata ka Ilekshon yn pyniaid da u Returning Officer u ban thung bad pynkup bor da ka Executive Committee.

Tangba ia ka jingthep vote ha kata ka Ilekshon ba pyniaid da u Returning Officer hapoh ka sub-rule (1) haneng kan long da ki Secret Ballot.

- (2) Tang kiba na ka jait kur Dolloi/Sirdar jong kata ka Elaka katkum ba pyni ha ka Appendix-II ki long kiba lah ban ialeh ia ka Ilekshon hapoh ka sub-section (1) haneng.
- (3) U Returning Officer un pynbna ia ka result hapoh shitaiew naduh ka sngi thep vote bad ai ia ka report jong kata ka Ilekshon hapoh ka sub-section (1) haneng sha ka Executive Committee ban ioh tip bad leh ia ki ba donkam.

**5. Jingthung Dolloi/Sirdar: -**

U nongialeh uba ioh bun tam na ki vote ba larkam ba la thep ha kata ka Ilekshon ba la pyniaid hapoh ka sub-section (1) jong ka Section 4 bad halor ka nongrim jong ka result ba la pynbna jop hapoh ka sub-section (3) jong ka Section 4 jong kane ka Ain, yn thung da ka Executive Committee kum u Dolloi ne Sordar. Ka Executive Committee hapoh laiphew sngi naduh ka tarik ba la pynbna ia ka result jong ka Ilekshon kan ai ia ka Sanad bad ki kyndon treikam kumba la

pyni thikna ha ka Appendix-II ia ka ban soi da u Executive Member ba dei peit ia ka kam synshar Elaka.

**6. Jingpynskhem Dolloi Sirdar: -**

Ia baroh ki jingthung Dolloi/Sirdar da kaba bud kat kum ka Rul 29 bad 30 jong ka Assam bad Meghalaya Autonomous District (Constitution of District Council) Rules, 1951 katkum ba la pynjari bad pynbit pynbiang da kane ka Council, Ka Executive Committee kadei ban buh ia ka report ha ka jingiashong Dorbar ka District Council kaba lah ban pynskhem ia kane ka jingthung Dolloi/Sirdar hapoh ki kyndon trei kam ba la pyni ha ka Sanad, lane ia kiba lah ban pynbna paitbah na ka por sha ka por. Napdeng kita ki kyndon trei kam ha kata ka Sanad yn kynthup ruh ia kine: -

- (1) Ka bainong.
- (2) Ka jingiadei bad ka District Council lane bad ka Elaka.
- (3) Ki rukom ha kiba ia ka jingsynshar Elaka dei ban bud.
- (4) Ki rukom ban pyniaid ia ka bai seng (fund) jong ka Elaka.
- (5) Ka akor ka burom.

Tangba, katba ym pat lah pynbit pynbiang ia kita ki kyndon ain, ki kyndon ain ba mynta ha kiba la thung ia ki Dolloi/Sirdar kin dang trei kam.

Shuh shuh kita ki kyndon ain kiba yn pynjari da ka District Council katkum kane ka Section kin trei kam mardor na ka bynta baroh ki Dolloi/Sirdar.

**7. Ka por bat kam u Dolloi/Sirdar: -**

- (1) U Dolloi un neh ha ka kam shi jingim.
- (2) U Sirdar ka Saipung Sirdarship un neh ha ka kam Sirdar 5 snem.
- (3) Ia ki Elaka ban thaw hapoh ka Section 3(2) kin don u Sirdar u ban neh ha ophis kumba san snem bad ym dei ban palat ia ka 10 snem hynrei lah ban jied biang ia u.

**8. Ki kyndon ia u nongialeh Ilekshon Dolloi/Sirdar: -**

Ia u briew yn ym lah ban jied bad thung ia u sha ka kam Dolloi ne Sirdar, lymda: -

- (1) U dei u nongshong Shnong tynrai ba shong basah ha kata ka Elaka.
- (2) U la dap 25 snem shaneng ka rata.
- (3) U dei uba na ka jaitkur Dolloi ba bit ban bat ia ka kam Dolloi jong kata ka Elaka. La kumta ruh, kane ka sub-section kan ym trei kam ia ka jingjied Dolloi/Sirdar ha ki Elaka ban dang thaw thymmai.
- (4) U briew uba biang ka jingmut jingpyrkhat.
- (5) U dei u bym don ki daw ban khanglad ia u ban ialeh Ilekshon halor ki nongrim ba don ki jingpalat ba u la leh, kiba pynlong ia u u bym bit ban bat

ia ka kam katkum ki dustur ba don pateng kiba dang trei kam ha kata ka Elaka.

**9. Ki kyndon Jingbymlah u candidate ban ialeh Ilekshon Dolloi/Sirdar: -**

Ia u briew yn ym lah ban jied bad thung kum u Dolloi/Sirdar jong ka Elaka lada: -

- (1) U bat ia kano kano ka kam (ophis) ba don bainong/tulop.
- (2) U long u bym biang ka jingmut jingpyrkhat, uba la pynbna kumta da ka ingbishar ne kano kano ka bor ba shongain bad ba la ithuh da ka District Council.
- (3) U dei u byn pat lait na ka jingdap ram.
- (4) Ha shwa ne hadien ba la don kane ka Ain, la ju don ka jingpalat ba la rai pynrem ia u hapoh ka Ain Indian Penal Code lane Criminal Procedure Code lane hapoh kano kano ka Ain ba pynjari ha Ri India, lane kano kano ka jingpalat ba pynhiar kyrdan ia ka akor long briew man briew.
- (5) U la shah beh kam na ka jingshakri hapoh kano kano ka Sorkar ne District Council ne ki local authority ne corporate body.
- (6) U dei u ba long dkhot sha Parliament ne State Assembly ne District Council ne local authority.

**10. Jingiakhajia ha ka Ilekshon Dolloi/Sirdar: -**

- (1) Lada jia ba don kano kano ka jingiakhajia halor ki kam ba don jingiadei ne iasnoh bad ka Ilekshon Dolloi/Sirdar ka liang ne ki liang ba pyrshah/bymhun kin thoh sha ka Executive Committee hapoh laiphew sngi naduh ka tarik ba pynbna result da kaba thoh sha U Secretary Executive Committee. Ka Executive Committee kan pyndep ia ka jingbishar hapoh hynriewphew sngi.

Haba leh ia kane ka Executive Committee, ka dei ban ailad ia ki arliang mamla ban said da ia lade.

- (2)(a) Ka apil pyrshah ia ka rai jong ka Executive Committee kan leit sha u Tribunal ban thung da ka Executive Committee na ka bynta kane ka kam bad u Tribunal un pyndep ia ka jingbishar kloi katba lah bad kan ym pallat ia ka hynriew bnai naduh ka tarik ba u la ioh pdiang ia ki kot ki sla (Case Record) bad ka rai u Tribunal kan long kaba kut.
- (b) Kano kano ka apil sha u Tribunal dei ban thoh sha u Secretary Executive Committee hapoh laiphew sngi hadien ba ka Executive Committe ka la pynmih ia ka hukum jong ka sha ki liang mamla.



(c) Ka Executive Committee kan thung ia u Tribunal bad phah ia ki kot ki sla (Case Record) sha u hapoh laiphew sngi naduh ka tarik ba la ioh ia ka apil.

**11. Weng kam bad sospon ia u Dolloi/Sirdar: -**

(1) Ia u Dolloi/Sirdar jong ka Elaka lah ban weng kam ne pynsangeh trei kam shipor (sospon) na ka kam da ka Executive Committee, lada ka shem ba:-

(a) u pynkhein ia ki kyndon ain ka jingthung Dolloi/Sirdar ia u;

(b) u pynkhein ia ki ain ki rules bad ki hukum jong ka District Council;

Lane

(c) u kyntait ban kohnguh ia ki jingbthah ne hukum ka Executive Committee;

Lane

(d) u pynkhein ia ki riti ki dustur ba ju bud da kata ka Elaka;

Lane

(e) lada shem ia u ba u banbein ia ki briew jong u bad ialam bakla ia ka Elaka;

Lane

(f) lada shem ba um don ka jingmut jingpyrkhat ba biang ban bteng ia ka jingtrei kam;

Lane

(g) lada u la shah rai pynrem na ka bynta kano kano ka jingpalat bad shah rai set patok ym duna ia ka hynriew bnai;

Lane

(h) u ba dap ram dap shah khlem lah siew;

Lane

(i) kiba bun na ki briew ba la san jong ka Elaka jong u kiba don ha ka Dorbar ba la khot khnang ban pynshisha ia ka jingkwah bad ka jingmut jong ki ha kano kano ka rukom ba la pynbeit da ka Executive Committee ki pynpaw ba ki la duh noh ia ka jingshaniah jong ki ia u;

(j) kiba bun na ki nongthep vote ka Elaka kiba thep ia ki vote(bood) jong ki ha ka ripharendom ba la pynlong khnang ban pynpaw ia ka jingkwah jong ki, ki la thep vote pyrshah ia u;

Lane

(k) lada shem ba um lah ban pyndep ne pyniaid beit ia ka synshar ka khaddar na ka daw ka koit ka khiah, jingshitom ka met, ka jinglong tymmen lane ka jingdih buaid tanglang lane ba um sah hapoh ka Elaka;

Lane

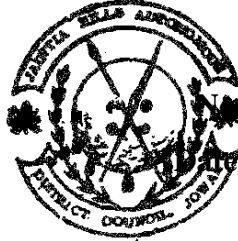

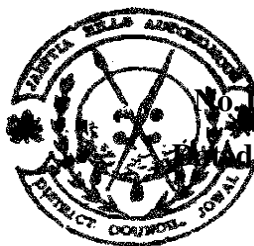
